This agreement is made as of this May 10, 2011

The following agreement has been approved and entered between INDAM – ISTITUTO NAZIONALE DI ALTA MATEMATICA "Francesco Saveri", Città Universitaria, P.le Aldo Moro 5, 00185 Roma (Italy) on the one part, and Springer-Verlag Italia S.r.l., Via Decembrio 28 – 20137 Milano (Italy) (hereinafter called Springer), acting in cooperation with Springer Science + Business Media B.V., Dordrecht on the other part to publish a new series of books in English language.

As a result of previous negotiations, every year INDAM will select and submit to Springer textbooks, multi-authors books, thesis and monographs resulting from workshops, conferences, courses, schools, seminars, doctoral thesis, and research activities carried out at INDAM. INDAM grants Springer the exclusive right to print (including "printing on demand"), publish, distribute and sell throughout the world the selected items and parts thereof including all revisions and/or future editions thereof and in any medium, such as in its electronic form (offline, online)."

This agreement records the intention of both partners to publish books in English language in the existing book program of Springer.

Copyright and Responsabilities

Springer will be responsible of any English language version worldwide. Furthermore Springer shall insert the copyright notice in all the editions of the works published, according to the provisions of the Universal Copyright Convention (UCC) and shall dutifully take care of all formalities in this connection, either in its own name or in that of the Authors.

Springer shall be responsible for the design and layout for the books in all media, including cover design and paper stock, the selection of paper and for determining the print runs.

Each book will include a note indicating the cooperation between INDAM and Springer, and the names of the members of the scientific Editorial Board that will be founded in order to select the contents for publication.

Springer shall be solely responsible for editorial development, design and production, marketing, promotion and distribution. In particular, Springer shall be solely responsible for planning, implementing and managing the promotion, marketing, and advertising of each new book publication to appropriate worldwide markets.

The initial general marketing plan will be sent to INDAM for further discussion and approval. INDAM will automatically receive all the e-alerts promoting any new publication.

2. Topics

The main focus of the series will be on books in mathematics and applications.

3. Editorial procedure and Contractual agreement

• Books will be published in softcover, and will be available both in print and electronic form. The electronic version may include full colour figures.

Springer is open to consider exceptions, thus publishing hardcover books if worthwhile (i.e. high level monographs, outstanding Multi-authors books).

Springer will handle the whole publication process, as already described and approved, starting from the official acceptance of a proposal.

The selection of books to be published, the referee procedure, and the communications with Springer will be handled by an independent Editorial Board to be founded by INDAM and communicated to Springer.

INDAM and Springer agree to publish at least 3 books/year, starting as of 2012.

INDAM is entitled to buy 50 copies of each book published under this agreement with a discount of 33,33% on the list price (higher discounts will be possible for a greater number of copies, i.e. more than 200).

INDAM, as well as the Editorial Board, will have free access to the electronic version of the series.

Springer provides the Editor-in-chief, and each member of the Editorial Board with 1 copy of each published book as a support for their scientific research.

Each member of the Editorial Board can obtain Springer books at a discount of 33,33% on the list price.

Once this agreement has been signed by all parties, INDAM will officially announce this agreement to its members, in order to promote and support this project.

4. Duration of the agreement

This agreement will be valid for 5 (five) years and will be tacitly extended for additional periods of two years subsequently unless notice is given in written form at least 12 months before the expiry date by either party. If the agreement is cancelled, Springer will retain publishing rights to the already published books

Regardless of the place of its execution, this agreement shall be deemed to be made under and shall be interpreted in accordance with the laws of Italy. For any dispute due to this agreement, attribution of jurisdiction is made at the competent courts of Milan.

To signify their agreement to the terms outlined herein, both parties have signed and exchanged this duplicate contract.
